Subject: - Provisional affiliation to Hari Narain Singh Institute of Teacher's Education, Vill. / P.O- Baijala, P.S. Sasaram, Dist. - Rohtas, Bihar-821 115 for starting Bachelor of Education programme of two years duration with an annual intake of 100 seats (two basic units of 50 each) for academic year 2016-17.

Sir,

It has reference to your proposal regarding granting fresh affiliation to your institute for above mentioned subject.

On the basis of the report of the Inspection Committee (which visited your proposed institute on 20-07-2016) and as per recommendation of 16th Meeting of Board of Affiliation of the university, your institute is granted provisional affiliation to Aryabhatta Knowledge University, Patna on the following terms & conditions:-

1. The provisional affiliation is presently for one year only for the session 2016-17.
2. The provisional affiliation is based upon the approval accorded to your proposed institute by the NCTE vide letter no. ERC/NCTE/APE00800/B.Ed.(Revised Order)/2015/32585 dated 31-05-2015.
3. The provisional affiliation is granted for 01 (one) course i.e. Bachelor of Education programme of two years duration with an annual intake of 100 seats (two basic units of 50 each) for academic year 2016-17.
4. This affiliation is subjected to attending to all the deficiencies pointed out by the NCTE & Inspection team (which visited on 20-07-2016) and to inform the university about the removal of all the deficiencies and fulfilment of other conditions as pointed out in NCTE letter & the inspection report under reference within a period of six months.
5. Further you have to inform the university through affidavit that you have removed all the deficiencies as intimated to you vide "4" above, failing which the provisional affiliation accorded through this letter shall be deemed to have been automatically withdrawn.
6. This affiliation is subjected to the condition of deposit of endowment fee of Rs. 5,00,000/- (Five Lakh) in the favour of Aryabhatta Knowledge University - Endowment Fund payable at Patna and Affiliation fees of Rs. 75,000/- (Seventy-five thousand only) per unit in the favour of Aryabhatta Knowledge University - Affiliation Fund payable at Patna, which must be deposited within a week from the date of receipt of this letter, failing which this letter will be automatically treated as withdrawn.
7. Rules/regulations, etc. regarding syllabus and conduct of examination etc. shall be communicated after all the conditions for provisional affiliations are met with by your institute to the full satisfaction of the University. In such a case no further correspondence shall be entertained.
8. The University may inspect your College at any working day without information to check the infrastructure of your College as per guidelines of NCTE/GoB/AKU.
